- 1. Call to Order/Announcements- Max Ellis
 - a. Meeting called to order at 7:02 pm
 - b. Board member introductions
 - c. Motion to approve April meeting minutes, seconded, motion passes
- 2. Bryan Square Park- Jason Green
 - a. The indoor portion of Bryant square will not be open until the Fall
 - b. Electronic panels being installed at end of May
 - c. Bathrooms will hopefully be reopening this summer
 - d. Leagues and summer camps are going on
 - e. Landscape work in progress
 - f. 15/18 concerts booked for the Music in the Park series
 - g. June 26th: Spiderman Far From Home movie in the park
 - h. Looking for part time help, reach out to Jason if interested!
- 3. Bryant Ave. Reconstruction Update
 - a. Trey Joiner, Liz Heyman
 - b. Currently in 3rd phase of feedback
 - c. 3 design options originally considered: Squeeze it in; Bikes on Bryant; Transit on Bryant
 - i. Bikes on Bryant is the current design that is moving forward. This would mean either a one-way or two-way for vehicles. The one-way option avoids a shared- use lane and adds more greenspace
 - ii. Converging one-way design
 - iii. 65-100 more vehicles on Lyndale as a result of this
 - d. Design Plans
 - i. All of these are available on reconstruction website
 - ii. Trying to maximize locations to plant tree. Need 4 feet wide boulevard space to do so
 - e. Q&A
 - i. Likely not to be a block by block construction; activities will happen simultaneously across blocks
 - ii. Greenspace actively treating storm water will be the city's responsibility. In other locations it would be the responsibility of the property owner
 - iii. SUNA has funding for bike-racks and graffiti prevention
 - iv. Parking is going to be constrained compared to what it is now
 - v. Been in contact with emergency services to ensure that proposals accommodate necessary services
 - vi. Bike way will be maintained by the city

 - a. Resolution to support one-way proposed design for Bryant Ave. Motion to vote on proposal; seconded; discussion about format; motion passes
 - b. Planning commission approves 3331 Hennepin project. Construction expected to begin by end of summer
- 5. Livability and Engagement Committee
 - a. Proposal for Bryant Park Ash tree treatment
 - i. 7 ash trees identified for treatment this summer
 - ii. Motion to use \$1350 of NRP funds to treat trees; seconded; motion passes
 - Discussion: treatment is not permanent, but they have been treated before. Ash trees make up a significant portion of the park trees. Company recommends to treat the trees every other year.
 - b. Music in the Park Series
 - 1. Funding for marketing and increasing intendance at concert series. Motion to use \$1,000 from expected contribution from community supporter for these events.
 - 2. Motion seconded; discussion; motion passes
- 6. Development Committee
 - a. Received finalized Strategic planning from consultants. Development committee will be meeting to further distill these results and provide reccomendations
 - b. Question about survey results, Engel will send these results to Gardiner
